1. Benefits

MEDICAL EXPENSES – ASSISTANCE – REPATRIATION

- Coverage or reimbursement of medical expenses **without deductible** to a maximum of **€500.000**
 - **Directly** in case of hospitalization
 - On return of the Insured for medical outpatient costs (consultations, pharmacy)
 - Reimbursement of emergency dental care, up to 70% of real costs, to a maximum of **€250**
- Medical repatriation by the emergency care centers
- Payment of a round-trip ticket and living expenses for a relative, in case of hospitalization of the Insured
- Payment of Return trip for the Insured, in case of death of a close relative
- Return with children
- Repatriation of the body in case of death
- Legal representative costs to a maximum of **€3.000**
- Bail advance abroad to a maximum of **€7.500**
- Cash advance to a maximum of **500 €**, in case of loss or theft of means of payment, passport...
- Search and Rescue expenses to a maximum of **€4.000**

TRAVEL CANCELLATION-MODIFICATION BENEFIT (relapses or worsening of pre-existing medical conditions included)

- Reimbursement of cancellation costs to a maximum of **€6.000** per Insured or **€30.000** per event, deductible €30, in case of :
 - Disease, accident, hospitalization or death of Insured, of family member or professional replacement of the Insured (liberal professions only), beforehand indicated in the membership form

The Insured and his/her spouse are also covered in case of:

 - Complications in pregnancy before the 8th month
 - Administrative or legal convocation
 - Convocation to a catch up exam
 - Lay-off
 - Important material damage at home requiring the imperative presence of the Insured
 - Serious damage to the vehicle preventing the Insured from going to the place of stay
 - Contraindications and vaccination after-effects
 - Obtaining a job for people registered as unemployed
 - Professional transfer involving moving house
 - Leave refusal due to the employer, deductible 25%
- Reimbursement of cancellation costs to a maximum of **€6.000** per Insured or **€30.000** per event Deductible 20 % of cancellation costs with a minimum of €150 per file, in case of impossibility to go abroad in consequence of incidence of **ALL** unanticipated events and independent from the will of the Insured which are not listed above, including terrorist attacks and acts in the country of destination, **EXCEPT :**
 - Any event harming the pleasure of trip only
 - Financial failure, the responsibility of the tour operator or the airline company
 - Cancellations due to the tour operator or the airline company
 - Cancellations resulting from vaccination oversight
 - Cancellations due to non-submission of necessary document for travel

INTERRUPTION OF STAY

- Reimbursement of unused benefits, to a maximum of €6.000 per Insured or €30.000 per event, due to emergency intervention, deductible €30.

PERSONAL LIABILITY

- Personal Liability benefit, deductible €80
 - Bodily injury to a maximum of €4.500.000
 - Damage to property to a maximum of €450.000

LUGGAGE

- Loss or theft of luggage during air travel to a maximum of €1.500 per Insured, deductible €15 per Insured
(For valuable item, reimbursement is limited to 50% of the amount of benefit)
- Luggage delayed more than 24 hours or flight delayed more than 6 hours, to a maximum of €150 per Insured within the limits of incurred costs.

PERSONAL ACCIDENT

- Payment of a lump sum of €8.000 in case of accidental death or disability
- Payment of a capital of €80.000 in case of air accidental death

DAMAGE TO HIRE VEHICLE, CDW/LDW (optional)

- To a maximum of the deductible amount or the compensation amount, maximum €22.000
